7. THE POLICY

I. PURPOSE

The purpose of the Continuing Education Policy is to establish a Continuing Education Program within the Bay Mills Community College.

The 1978 Tribally Controlled Colleges and Universities (TCUs) Assistance Act allows Continuing Education Unit credits awarded by BMCC to be applied toward the calculation of a TCU's Indian Student Count. A CEU is a uniform unit that measures individual participation in noncredit continuing education.

To award and count CEUs, BMCC must create and maintain their CEU program according to the criteria established by the International Association of Continuing Education and Training (IACET). Accordingly, the BMCC Continuing Education Program and its policies and procedures shall adhere to the criteria established by IACET and federal regulations.

The formation of the BMCC Continuing Education Program shall include the Academic, Admissions and Registrar Departments, Faculty and Instructors, and a Continuing Education Program (CE) Coordinator.

II. CONTINUING EDUCATION MISSION

The BMCC Continuing Education Program will serve the College's mission by developing and executing continuing education and lifelong learning opportunities for industry professionals and community members in collaboration with the Academic Department and institutional partners.

III. DEFINITION OF A CONTINUING EDUCATION UNIT

BMCC defines a Continuing Education Unit in accordance with 45 CFR 41.5(F):

- (f) Add to the calculation in paragraph (b) of this section those credits being earned in an eligible continuing education program at the conclusion of the third week of the academic term. Determine the number of those credits as follows:
- (1) For institutions on a semester system: One credit for every 15 contact **hours** and
- (2) For institutions on a quarter system: One credit for every 10 contact hours of participation in an organized continuing education experience under responsible sponsorship, capable direction, and qualified instruction, as described in the criteria established by the International Association for Continuing Education and Training. Limit the number of calculated eligible continuing education credits to 10 percent of your ISC. 25 CFR 41.5(f)
